The information below is based on the most updated research done by Pre-Health Dreamers (PHD). Please note that this information is subject to change. We recommend that you use this document as a starting point to begin your journey in researching professional programs. This document was created to help support individuals who have Deferred Action for Childhood Arrivals (DACA), Temporary Protective Status (TPS), or who do not have a Social Security Number (SSN).

<p>Acceptance</p>	<p>U.S. Residency or Citizenship admission requirements and support for undocumented students vary by institution and program. Prospective students should research and contact the school at least one year in advance or more before they apply to start these conversations. We encourage individuals to explore public and private universities options, as well as programs that have previously admitted undocumented students and programs that have not.</p>

Financial Aid	<p>We advise students to reach out to the programs they are interested in at least a year in advance to research if financial aid is available to undocumented students.</p> <p>Pre-Health Dreamers has created a Financial Resources page for undocumented students seeking educational funds. Students have historically used leading private lending companies. A select number of loans are available for DACA/TPS students without a US citizen co-signer.</p>

Clinical Requirements	<p>Most schools require at least 2 years of clinical clerkship rotations during 3rd and 4th year of medical school. Clerkships vary from 4- 8 weeks rotations and include internal medicine, general surgery, OB-GYN, pediatrics, family medicine, psychiatry, neurology, etc.</p>	<p>Clinical preceptorships may be integrated with classroom education. Students receive hands-on experience in a variety of healthcare settings and specialties. Preceptors and clinical sites are specific to each program.</p>	<p>Most dental schools have their own dental clinics for student training. Clinical rotations will usually occur during the last two years of the dental programs. Clinical rotations typically have no extensive traveling requirements.</p>	<p>1,500 internship hours are required to graduate. Students apply for licensure as 1st year students.</p> <ul style="list-style-type: none"> Licensure requirements vary by state. Verify the states you plan to apply to provide professional licensures to individuals with ITINS. <p>Clinical experiences begin early in the program but can vary.</p>	<p>Clinical rotations for the latter half of the program. ★ Verify with your state licensing board if licensure can be obtained using ITIN instead of a SSN.
